

**VILLAGE OF UPPER NYACK
ARCHITECTURAL REVIEW BOARD MEETING
Monday, July 11, 2022**

Minutes

A meeting of the Architectural Review Board of the Village of Upper Nyack was held on the above date and called to order at 6:00 pm by Chairman Michael Williams.

6:00 pm: Chairman Michael Williams opened the meeting and asked for a motion to open the meeting.

6:04 pm: **Peter and Jaime Marino, 106 School Street, County Map No. 60.17-02-61.**

Application for architectural review of a kitchen renovation including changing back door to a sliding door and adding a pass through from the kitchen to the dining room.

The Applicants were represented by Peter Marino, one of the homeowners.

Mr. Marino explained that this renovation of adding a pass through from the kitchen to the dining room and changing the back door to a glass sliding door served two purposes—to improve the aesthetics and to make the areas more functional.

The Board discussed that the finish schedule for the door was not in the packet of board member materials. The applicant stated that it is a five-foot door. Vice Chair Gretchen Reinheimer inquired whether it would be painted to match the trim around the house. The applicant said that it was aluminum and white. The Chairman directed the applicant to amend the finish schedule to include that information. The applicant amended the application and completed the finish schedule to indicate the material and that the color will match the color of the front door.

Member Eileen Sares made a motion for architectural approval of the addition of the pass through and changing the back door to a glass sliding door on the property located at 106 School Street. The approval is subject to the plans dated June 30, 2022 titled Kitchen Door Reno. and submitted to the Architectural Review Board on July 1, 2022 by BOLT Architecture, PLLC.

6:14pm: Soraya Scroggins and Adam Budgor, 11 Tompkins Court, County Map No. 60.14-01-12.7.

Referral from Planning Board. Application for architectural review of a residential renovation of existing dwelling with site landscaping and pool renovation on a property improved with an existing single-family residence located in the Residence R-30 District.

The applicants were represented by the homeowners, Soraya Scroggins and Adam Budgor; the architects, Chris Coy and Lauren Zucker from Barnes Coy; the landscape architects, Ian Hanbach and Justin Leanza from LaGuardia Design Group.

Adam Budgor introduced himself and his wife, Soroya Scroggins. He explained why they chose Upper Nyack as their home; and turned the presentation over to Chris Coy.

Mr. Coy explained that the applicants have appeared before the Planning Board and received variances from the Zoning Board of Appeals for the proposed project. He said that their approach for this transformation was to take advantage of the river views; not changing the basic shape of the house.

Vice Chair Gretchen Reinheimer asked about the actual glass and whether there would be any glare effects.

Lauren Zucker stated that the glass is Starfire Low E and it is absolutely clear.

Chairman Michael Williams expressed concern about glare.

Vice Chair Gretchen Reinheimer asked about the finish for the metal around the windows. The applicant presented the board with an example piece of the window casement material. They explained it was an aluminum alloy clad in a black coating that has a 40-year life span. They represented that they had a material specification that supported that claim.

There was a landscaping discussion.

Vice Chair Gretchen Reinheimer asked a question about the handrail and whether it, too, was glass.

Chairman Michael Williams stated that there was a question from the board member who is absent. He asked about the infinity pool. He said it shows the infinity pool spilling into the trough around three sides of the pool; and shows the infinity edge on the west side with nowhere to spill. It was explained that the water goes over into a slot into a collection area.

Vice Chair Gretchen Reinheimer asked about the garage door and whether it was the same Starfire glass...see through or obscure. Discussion about the materials ensued.

Chairman Michael Williams confirmed it is translucent and not reflective.

Member Silvia Luzi asked about the shape of the patio. She asked what the idea of the geometric shape is.

It was confirmed that the idea was to enhance the view.
