After discussion, the Board noted they could consider a local law that would prevent a resident from parking or storing a boat, RV, ATV or Pod in their front yard. Further discussion would need to take place.

Mr. Grand also questioned the Board as to when North Midland will be paved? Mayor Esmay noted that once the sanitary sewer project is complete N. Midland will get paved. Drawings are being prepared for bids to be requested and the hope is that it can be done within a year.

Mr. Grand also suggested better communication with residents such as during the recent Hurricane Sandy storm.

Mayor Esmay told Mr. Grand that the Town of Clarkstown sent notice out to its residents requesting information to use for reverse 911 calls. The Village met with representatives of O&R who handle emergencies to discuss what was done and what could have been handled better?
