DRAINAGE-DISCUSSION:

Sue Smith & Jen Hatch, 311 North Broadway- Sue Smith spoke before the Board and noted they have lived on North Broadway since 1997 and had not experienced any water problems until recently. Three times in the last year have had significant water coming onto the property and causing damage to the property (photos submitted). They also noted that the catch basin near their property had narrow outlet, restricted by thick paving and wondered if anything could be done?

Mayor Esmay read letter that the Village Engineer helped to formulate to explain the Village's position on water and drainage in the village. (Attached)

Michael Sperling, 317 North Broadway, came in after Sue Smith spoke but added his concern about the narrow opening of the catch basin and whether opening it up would help?

Trustee Morgan noted that the larger opening can also allow debris to get in and clog the basin.

Mayor Esmay said there would continue to be ongoing discussion by the Village Board in conjunction with the Village Engineer due to so many unusual storms.

CITIZEN COMPLAINT-

Thomas Knarich& Jayne Knarich, 411 Glen Avenue James Shaughnessay & Shaw Dowd, 216 Elm St.

All appeared before the Board to follow up on a complaint regarding the Firetech property on Route 9W that abuts their properties. The property is unkempt, overgrown and has multiple unregistered vehicles being warehoused there. They would like a violation posted on the property.

The Village Code enforcement officer has written to Mr. Bertolino, the property owner regarding his tenant and that the property needs to be cleaned up. The Code enforcement officer has been working with the tenant but the clean up is not happening quickly or to the neighbors' satisfaction.

The Village will ask the code enforcement officer to continue to require the clean up by the tenant or post a violation on the property and to the owner.
