RESOLUTION ADOPTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF UPPER NYACK ON SEPTEMBER 16, 2010.

WHEREAS The Rockland Farm Alliance (RFA), a 501(c)3 community agriculture advocacy organization dedicated to preserving and creating farms in Rockland County, has asked the Town of Clarkstown to be the municipal applicant for a grant from the Hudson River Valley Greenway, in order to request funds to develop and implement a community farm (The Cropsey Community Farm) in New City, and

WHEREAS, the Town of Clarkstown has agreed to act as fiscal agent on RFA's behalf in pursuit of a grant from the Hudson River Valley Greenway, and

WHEREAS the RFA has submitted a detailed plan for to Rockland County for development of the Community Farm, including an educational component and a farm to school initiative that is designed to benefit Clarkstown Schools and Rockland County has issued a license agreement to the RFA to develop the Cropsey Community Farm, and

WHEREAS the RFA has completed the assessment tools program Keep Farming© under the guidance of The Glynwood Center, and has the ongoing support and guidance of the Natural Resources Conservation Service, The Glynwood Center and the USDA's Lower Hudson-Long Island Resource, Conservation and Development Council in development of this project, and

WHEREAS the Village of Upper Nyack has always been supportive of local farms in Rockland County and believes that these farms are essential to the health, well being and quality of life of Rockland County residents,

NOW, THEREFORE BE IT RESOLVED that the Board of Trustees of the Village of Upper Nyack supports the application submitted by the Town of Clarkstown to the Hudson River Valley Greenway for a grant to support the development of the Cropsey Community Farm.
