The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held at the village hall on Thursday, November 21, 2019 at 7:00 PM.

POLICE REPORTS - PO Kennedy attended and presented the report.

Discussion: Since 10/18/19, There were 179 calls for service; 3 motor vehicle accidents; 24 alarms (fire & burglar); 38 medical emergencies; 24 school checks; area checks; 3 parking tickets & 15 Uniform Traffic tickets issued.

Overdoses: Rockland County: Year to date: 196 (41 deaths, 155 survived)

Clarkstown: Year to date: 57 (9 deaths, 48 survived)

Discussion: Parking at Nyack HS during football games: overflow is sent to the Alliance Seminary property and safety cones are placed along 9W for walking to and from the high school

Clerk gave information to CPD re: the Nyack Hunger Coalition Resolution Run and the Nyack Community Ambulance Corp. Snowflake Run/Walk

<u>TREASURER'S REPORT</u> – Treasurer Fortunato submitted the report for review. Delinquent unpaid property tax payers list was submitted to Rockland County Finance office, for the amount of \$21,017.45.

\$4,172.86.00 in interest has been earned from the NY Class accounts. The Treasurer asked the Board to consider resolutions for two bonds.

Temporary Moratorium on new special permit applications

The Clerk read the public hearing notice.

Mayor Tarapata noted that the committee has been working on and the

Comprehensive Plan update, including improving the special permit process, and the draft is close to completion. While the reviews of outside agencies and public hearings take place, it is wise to put a moratorium in place.

The Mayor replied yes. Mayor Tarapata noted there would be a SEQRA review, public input, and zoning updates.

Trustee Diamond motioned to close the public hearing, seconded by Trustee Rothchild and it was so moved.

Discussion: Farm Family Insurance settlement for River Hook Preserve. Mayor discussed with Village Attorney and Board and all agreed Mayor should sign.

Trustee Esmay made a motion to adjourn, seconded by Trustee Dodge and so moved. The meeting was adjourned at 8:15 PM.
