# REGULAR MEETING June 20, 2019

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held at the village hall on Thursday, June 20, 2019 at 7:00 PM.

<u>POLICE REPORT</u> – PO Kennedy appeared and presented the report. There were 229 calls for service; 50 area checks; 21 school checks; 6 minor vehicle accidents; 40 medical calls; 5 V&T tickets; continuing to check Houses of Worship, UNES, Field Club and 116 Castle Heights Ave (incident noted)

Mayor Tarapata spoke to PO Kennedy about overnight parking and need for enforcement on specific streets.

SCAMS- Reminder not to keep valuables visible in vehicles; roofing, driveways, Medicare card (new-call states that person needs new temporary card and should provide info and \$50)

Discussion regarding overdoses. In New city there were 23 od's year to date (5 resulting in death) and in Rockland County 90 od's year to date (20 resulting in death)

A new program is being established (Piermont has had one in place for about 60 days) called Hope not Handcuffs Partnership. An addict can turn themselves in to any law enforcement and ask for rehabilitation instead of being arrested.

TREASURER'S REPORT – Submitted for review from Treasurer Fortunato. Treasurer Fortunato noted that the Public Improvement/Sewer bond payment for interest will be due on July 15, 2019 Trustee Diamond made a motion that the Board allow the Treasurer to pay the bond interest payment of \$23,359.38, seconded by Trustee Esmay and it was so moved.

The Mayor will sign the MOU and the clerk will forward to Joule Assets Inc.

1) Local Law #2 of 2019 – <u>Laws governing the use of River Hook</u> <u>Preserve (RHP)</u>
