# REGULAR MEETING May 16, 2019

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held at the village hall on Thursday, May 16, 2019 at 7:00 PM.

<u>POLICE REPORT</u> – Officer Kennedy appeared to present the monthly report. Discussion: Officer Kennedy informed the Board that there were 192 calls for service, 6 motor vehicles accidents, 13 alarms, 33 medical calls, 62 area checks, 13 school checks, 2 parking tickets and 7 uniform traffic tickets.

SCAMS: Continue to be aware of the following scams: painting, paving, IRS (less so) Utility workers.

There were 74 overdoses in the county. 15 in Clarkstown with 4 ending in deaths. The CPD will provide assistance and barricades for the events on May 23, 2019 (Summit School run) and June 8, 2019 (Goosetown Bazaar –UNES)

The Village and CPD will coordinate on the locking gate at the HHCP that will be

installed. An electronic gate was cost prohibitive.

TREASURER'S REPORT – Treasurer Fortunato submitted report for review. Treasurer Fortunato requested a resolution of the Board to allow him to pay the bond for the Preserve of \$55,000 principal and \$90,000 interest due 6/15/19. Trustee Esmay made a motion that the Board approve the payment for the bond, as the Treasurer recommends, seconded by Trustee Rothchild and so moved. ## Discussion and Comment by the public:

Peggy Kurtz spoke to those assembled and noted that the process can take 4-9 months as other municipalities pass legislation and the communities are bundled together. All residents would be notified and any new residents would review the same letter, including information on opting out. Real estate agents should be made aware that the program exists.

South Nyack passed legislation and Nyack was holding a public hearing the next week.

Ms. Kurtz noted her committee had looked at several energy companies. Joule, Good Energy (National) and Mega Energy (not in the Hudson Valley yet) They based all their reviews on the following criteria: 1) cost 2) Outreach and whether they were working locally 3) Did they promote renewable energy (direct buying from renewable sources) 4) hands on? 5) Any negative reviews about the company

The idea is to not cut ties with current utilities but to have the choice of renewable energy

Bob Stein told the Board of Trustees he was grateful for the work of the committee Dan Wolff was grateful for the Boards willingness to offer this to the residents Dan Garcia, running for Town Council (Ward 2) came to offer the Board his full support.

Alan Bigelow stated he was happy to meet like-minded people. Mr. Bigelow recently moved from Hastings-on-Hudson, where they had recently adopted the CCA legislation. He was very much in favor of it.

Trustee Rothchild moved to close the public hearing, seconded by Trustee Dodge and it was so moved.

<u>ROCKLAND BICYCLE CLUB-</u> Dave Zornow, working with Michael Hays (who was unable to attend) appeared before the Board, requesting to hold an event for the Rockland Bicycle Club called the "Slow Roll", on Sunday, June 2, 2019 beginning at 2 pm.

The idea behind the event is to get riders out and to increase comfort level and safety for riders on the roadway.

The club will provide COI to the Village. Each rider must sign a waiver with the club. The event will be coordinated with CPD.

Trustee Rothchild motioned that the Board permit the Rockland Bicycle Club to ride through Upper Nyack from the UNES to Nyack Beach State Park and back to the Hopper House in Nyack, seconded by Trustee Dodge and so moved.
