REGULAR MEETING January 19, 2017

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held at the Village Hall on Thursday, January 19, 2017 at 7:00 PM.

Deputy Mayor Esmay presided over the meeting because Mayor Hindin resigned as Mayor on 1/13/17 for personal reasons.

<u>POLICE REPORTS</u> – Lt. Morgan appeared and presented the CPD report to the Board.

There were 85 incidents; 36 were elevated to cases (majority were medical emergencies)

Overnight parking: There has been more aggressive enforcement

Summit School: 3 incidents were reported of emotionally disturbed persons.

Students transported to Nyack Hospital without incident.

PO Valerio has been following up on the resident who has been parking at the top of Bliss Lane at Hilltop Lane, blocking Bliss Lane. Deed states ingress & egress be allowed from Hilltop and from N. Midland. Cannot block the lane.

Other incidents reported: 2 loose dogs near Jewett Rd.; debit card fraud from online purchase (Police following up); call of shots fired on Tompkins Ave (unfounded); possible coyote sighting

The Snowflake Run and Resolution went on without incident.

TREASURER'S REPORT – Treasurer Fortunato submitted the report for review. 1099's were mailed. Bond payment was made as per instructions of the Board. Discussion: DPW safety clothing allotment \$500 each year at Rugged Outfitters. Deputy Mayor Esmay noted that he had approved the purchase of plow blades at a discounted cost.
