REGULAR MEETING April 21, 2016

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held at the village hall on Thursday, April 21, 2016 at 7:00 PM.

POLICE REPORTS - Lt Steve Morgan reported to the Board.

Discussion: Lt Morgan noted there were 44 incidents and 20 of those reached the level of an official report. Reported were an identity theft (home health aide); suspicious incident (resident not receiving mail, checked with the post office and a request to PO to hold their mail had been received); Non-criminal property damage-mailboxes knocked over (garbage carter to pay restitution to homeowner)

Lt. Morgan noted the house at 519 N. Midland is vacant and being vandalized and young people beginning to congregate. Asked that our building inspector notify the homeowner to secure the building and leave some lights on.

Lastly, a car was retrieved from a ditch. Resident retrieved from police station.

V&T = 9, 6 parking tickets

Elementary School- Evidence of young people congregating behind the school Summit School- 1 report of an emotionally disturbed person. Taken to Nyack Hosp.

Lt. Morgan was asked by the Board to comment on the proposed installation of a stop sign at Roseland & Glenbrook Roads. Lt Morgan commented that there were not a flood of complaints nor accidents at this intersection. The Police can conduct a traffic study of the intersection.

Karen Olsen, 405 Roseland Road spoke on this matter. Ms. Olsen indicated that this was not a busy nor dangerous street. She allows her kids to be out there. Feels the stop sign is unnecessary. Feels trees and vegetation at the intersection more of a hazard because it creates a dangerous line of sight problem.

<u>UNES PTA</u> — Chrissy Place appeared representing the PTA. She came to thank the board for the use of the OSMH for the FARMIGO ongoing fundraiser. She feels it had been a great community program as well as a PTA fundraiser. They have signed up 83 members. 25% are Non Upper Nyack Parents. They have sold \$22,000 worth of groceries and 10% or \$2,200 has gone to the PTA. It is one of their most successful fundraisers. This has given them the funds to revitalize the school garden. This is the most successful FARMIGO launch nationally. They have already expanded the number of local products they carry. Local produce is not always found in grocery stores.

The PTA would like to continue through the summer and into the next school year. The Board asked that Chrissy Place write a letter to the Board with the request to continue and the Board would review it at the next regular meeting.

<u>TREASURER'S REPORT</u> – Treasurer Fortunato submitted the report for review. <u>VOUCHERS</u> – Read and approved for payment.

Discussion: Abstract & non-invoice items such as bonds, CDs etc.; FDIC limits for municipalities \$250,000 for checking and \$250,000 for savings; Accounts can be condensed with funds specifically identified and in safe investments; bank can send an annual report (summary) or monthly

The new bank accounts at Sterling will be opened in May. There will be 5-7 accounts. All new revenue deposits will begin June 1, 2016. Current Chase accounts will remain open until June 30th to allow items to clear.

Treasurer Fortunato requested that any cash disbursement about \$50,000 would require two signatures

Trustee Tarapata made a motion that the Village of Upper Nyack consolidate funds and move from Chase Bank and M&T bank to Sterling National Bank, and authorize that any cash disbursement payment above \$50,000 require two signatures (any two of Treasurer, Village Clerk, Mayor or Deputy Mayor), seconded by Trustee Esmay and so moved. The DPW researched the cost for a new truck and it came in lower than anticipated. The increase is under 1%. The Board reviewed the proposed budget.

In the absence of any questions or comments by the public, Trustee Esmay motioned to close the public hearing which was seconded by Trustee Diamond and it was so moved.

Trustee Diamond motioned to adopt the Tentative Budget as amended to stay within the property tax levy limit, and it will become the Actual Budget for 2016-17 seconded by Trustee Nye and with no further discussion, it was so adopted.

Discussion: Karen Olsen, 105 Roseland Road, spoke to the Board regarding the addition of a stop sign at the intersection of Roseland Rd. & Glenbrook Road. Ms. Olsen does not feel a stop sign is necessary there. She has lived on the street for a long time and there is very little traffic or issues. She does feel that the vegetation growing at that intersection creates a hazard. Lt. Morgan offered that the CPD could do a traffic study and report back to the Board. The residents of the property will be informed again about their overgrown trees and the safety concern at that intersection.
