## REGULAR MEETING May 21, 2015

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held at the village hall on Thursday, May 21, 2015 at 7:00 PM.

POLICE REPORT - Lt. Morgan attended and presented the report.

The recent bike event Gran Fondo went well.

CPD are using Traffic Safety grants to conduct seatbelt checks, DWI checks and other traffic safety stops.

Did a recent monitoring of speed of cars on North Broadway in the north & southbound lanes. There was not a lot of volume except during 5-6 pm, a typical rush hour time. The traffic speed sign will be placed along the roadway.

Discussion took place on the following: Report of juveniles hanging out at the top of upper Badi Dr & end of Radcliffe Dr.; 43 reported incidents or calls for service; 33 V&T-assorted tickets, warnings & violations; continuing to monitor phone scams; heroin overdose (Rt 9W & Christian Herald Rd)

Noise Ordinance: Lt Morgan explained that the Clarkstown Noise Ordinance does not use decibels; based on time. The Board has been in discussion with Lt Morgan and CPD regarding complaints of noise. Lt Morgan's recommendation was to not consider modeling the Village Law on the Piermont Law which is based on decibels.
