REQUEST FOR ADDITIONAL STREET LIGHTING

The Board decided that it would be best to survey the area at night and also Lt. Morgan of the Clarkstown Police offered that the police could check the area and note what would be appropriate for security and safety. THE CPD will contact the homeowner.

Mayor Esmay, Trustee Tarapata and Donna Albert, Court Clerk, will be meeting at the Town of Clarkstown with Supervisor Gromack, Town Attorney Miele, Candace Draper-Town Court Clerk to discuss the transition of the closing of the Upper Nyack Court to

Clarkstown. They will discuss absorbing our Court Clerk into their Court system temporarily to help close out open cases.

7:30 PM Public Hearing-Renewal of Franchise of Cablevision of Rockland/Ramapo LLC

The Mayor opened the public hearing and asked the Village Clerk to read the public hearing notice.

Mr. Robert Hoch, Counsel for and representing Cablevision of Rockland/Ramapo LLC to correct an administrative error on the part of Cablevision to send the renewal to the Public Service Commission within one year of the Boards approval of the agreement which was approved at a public hearing held on July 18, 2013. The public hearing is being held tonight to reconsider that same agreement. During the discussion, Mr. Hoch noted the addition of language regarding "level playing field." Cablevision provides service and Verizon provides grant money in lieu of service.

Mayor Esmay opened the public hearing to the public. With no one from the public in attendance, there were no comments.

After a brief discussion and with the testimony presented tonight Mayor Esmay and the Board were in agreement that the Board should approve the renewal.

<u>POLICE REPORT</u> – Lt. Morgan attended in place of the Community Policing Officer Paul Valerio who was ill and unable to attend. Lt Morgan noted there were not a lot of incidents in the Village. He also noted that the CPD is looking to be more responsive to community needs. They are retooling how they look at traffic, using enforcement and calming effects. Mayor Esmay inquired if recommendations would be made to the Board and Lt. Morgan affirmed there would be.

Lt Morgan also noted that CPD would provide support during Halloween celebration. Auxiliary Police will be provided and use of reverse 911 calls to alert residents of street closings during the event.

Trustee Hindin made a motion that the Board approve the closure of North Broadway from the north side of Highmount Ave. to the south end of Birchwood Ave. and Castle Heights Ave. from North Midland Ave. to North Broadway during the Halloween activities around Village Hall and the Firehouse, seconded by Trustee Morgan and so moved.

Dear Village Board:

Section 2019-a of the Uniform Justice Court Act requires that village justices annually provide their court records and dockets to their village auditing board(Village Board), and such records then be examined or audited and that fact be entered into the minutes of the board's proceedings.

In accordance with the requirements of the above paragraph, I have analyzed the records of the Village of Upper Nyack's Justice Court to determine adherence to court procedures and compile relevant operating data. Attached please find an analysis of the Court's operating data for the fiscal year June 1, 2013 – May 31, 2014.

In summary the Village's Justice Court collected fines totaling \$41,971. Of that amount the State of New York determined its share to be \$16,925. The Rockland County share of fines amounted to \$1,680. The remaining balance totaling \$23,366 represents the Village's share of fine income for the fiscal year.

I hereby recommend that the Village Board examine this report, and lacking any further comment, accept same as a complete accounting of the Village of Upper Nyack Justice Court for the fiscal year June 1, 2013 – May 31, 2014. Please contact me should you have any questions or require further information.

Please note that as of May 31, 2014 the Court Bail bank account held the amount of \$300 in escrow.
