REGULAR MEETING December 19, 2013

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held at the village hall on Thursday, December 19, 2013 at 7:00 PM.

<u>POLICE REPORTS</u> – PO Hodges submitted reports for review. Incidents discussed were: certified check scam, drug arrest, dead deer deposited into a dumpster on 9W, No Parking sign knocked down on N. Midland near Highmount, Summit School – harassment and a student struck another student.

Resident Laura Yassky Glynn of 214 Radcliff Dr., came before the Board to discuss an ongoing issue on her street and at the deadend where the trailhead is located. Chairs and a campfire are used by groups of teens. Also has noted drug activity with cars parked in front of her house where she has found drug paraphernalia, condoms and trash on the ground. On one occasion while putting out her recycling she was told by one of the occupants in the car to go back inside her house. Ms. Yassky has concern for herself and her property.

PO Hodges noted that he will do an area check 1-2 times per week and ask other officers to do that also. PO Hodges also stressed that she not approach anyone and to always call the police every time she witnesses any activity.

Peter McGroddy agreed that regular checks would help to make them more comfortable. The residents also discussed the possibility of a street light being installed at that location. The clerk was asked to check with Clarkstown and the lighting district to get procedure to have one installed and report back to the Board.

Trustee Hindin made a motion that the village investigate with the Clarkstown Lighting District the different lighting features /fixtures for a light at the end of Palmer/Radcliff and if possible to install said light if agreed upon by all parties, seconded by Trustee Diamond and so moved.
