### REGULAR MEETING July 19, 2007

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held at the village hall on Thursday, July 19, 2007 at 7:00 PM.

<u>POLICE REPORT</u> – Read and noted. 44 summons were written; 20 written in overnight hour. Traffic Counters will be put in place last week of August and after school begins. Traffic Officers were notified of No Left Turn at Glen Ave. & Rt. 9W <u>JUSTICE REPORT</u> – Read and noted.

<u>Tara Stark, 200 Oak Hill Drive</u> – Ms. Stark appeared before the Board to request approval to place a stone wall in the village right-of-way. A landscape contractor has appeared twice before on their behalf. The Board voted previously (3 to 1 against) to not approve the request.

The homeowner would still like the Board to consider the request. They want to create a barrier to keep their children from entering the street if chasing a ball.

Trustee Morgan noted the right-of-way is public property for municipal purposes. Trustee Anderson thinks a rock wall is a massive structure that would be difficult to move.

Mayor Esmay tried to understand the reasoning. Why in the right-of-way? Trustee Malcolm noted that there are other areas in the village where things have been built in the right of way and has led to problems. An example is lower Birchwood Ave. The Board is considering a sidewalk in the future and steps and pillars and trees have been placed in the right-of-way and will have to be removed.

Mayor Esmay also noted that the right-of-way is really a walkway for the public. The Board decision stands. No to building a stone wall in the R.O.W.

# Lee Taylor, 422 Glen Avenue- Request to remove guardrail.

Mayor Esmay noted that the former Superintendent of Public Works was not in favor but new Supervisor is in favor, so it will be reviewed. Mayor asked Supervisor to look at the area and report back.

Lee Taylor appeared before the Board regarding a previous request to move the guardrail at the end of Glen back so the snow plowed into that area in winter does not block their front steps.

Mr. Russell Beck, 419 Glen Avenue, has resided there for 18 years. Wants the area to stay green. Does not want pavement extended if Guardrail is removed. Also would like the fence section that was removed from along parking lot of restaurant replaced.

Mr. Beck commended the service of Mr. Scanlan and was sorry to see him go.

Mr. Beck was also concerned about the drain that is in place at the dead end. Would not want its operation compromised.

Trustee Tarapata would like to reach a compromise that is amenable to both neighbors. Mayor Esmay stated that he would want to wait for the report and recommendation from the Supervisor of PW before coming to a decision.

Mr. Beck requested that he be a part of any on-site meeting that takes place so he can have his concerns considered.
