REQUEST FOR STREET CLOSING -

Trustee Smith made a motion authorizing the closing of North Broadway between Castle Heights Avenue and Birchwood Avenue for the Upper Nyack Elementary PTA Goosetown Bazaar from 9:30 am until 3 pm on Saturday, May 21, 2005 and that they provide a Certificate of Insurance naming the village as additionally insured, seconded by Trustee Tarapata and unanimously approved.

The Village Clerk will send a letter notifying the residents of North Broadway, Perry Lane and lower Castle Heights Avenue of the closing. The Clerk will also notify the Clarkstown Police liaison officer so that auxiliary police can be provided. The Village of Upper Nyack DPW will supply saw horses to block off the street.

GEORGE WASHINGTON BRIDGE CHALLENGE

Having received a request from the group known as the 2005 George Washington Bridge Challenge, Trustee Morgan made a motion that the Board of Trustees approves the George Washington Bridge Challenge passage through the Village of Upper Nyack on June 5, 2005 and that the village will accept the status as additionally insured, seconded by Trustee Smith and so moved.

SCHOOL STREET PARKING — Joseph Heider, 316 North Broadway (corner of School Street) came before the Board to discuss a problem he is having with cars being parked to the east of his driveway on the south side of School St.. Mr. Heider noted that since the time the Village legitimized the parking for the residents of the row houses people are parking to the east of his driveway which has left an increase of garbage on the street because the street sweeper can't get to that area and it also interferes with snow plowing. The cars have not been ticketed by the Clarkstown Police because they are off the paved portion of the road.

After hearing from Mr. Heider and discussing the issue, the Board took the following action:

Trustee Tarapata made a motion to hold a public hearing on April 21, 2005 (this was later changed to April 14, 2005 and published in the legal notice as such), to consider amending Ordinance 2.2(e) of the 1965 Code of General Ordinances, Parking of Vehicles, to forbid parking on the south side of School St. a certain distance from North Broadway (to be measured by the Superintendent and included in the language of the law) to the driveway of the residence at 316 North Broadway and to install no parking signs, seconded by Trustee Morgan and so moved.
