


## DO I NEED A PERMIT BEFORE BEGINNING NON-EMERGENCY TREE REMOVAL?

Village of Upper Nyack Tree Preservation Law, Local Law 4 of 2021



### DEFINED TERMS

**DIAMETER AT BREAST HEIGHT (DBH):** The trunk diameter of a tree as measured from a point that is 4.5 feet above the ground.

**SIGNIFICANT STAND OF TREES:** Five or more Trees of the same or similar species clustered to form the same Dripline.

**SIGNIFICANT TREE:** Any living, woody plant with a DBH that is equal to or exceeds 12 inches, or, if any portion of the proposed Tree is located on a Steep Slope, within 100 feet of the Hudson River, or within a federal, state or locally regulated wetland a DBH that is equal to or exceeds 8 inches.

**STEEP SLOPE:** A portion of a Lot with an average gradient of twenty percent (20%) or more, extending over any horizontal length of at least fifty feet (50') and extending over a horizontal width of at least fifty feet (50').

**TREE:** Any living, woody plant which has a DBH of six (6) inches or more.

\* Certain tree removal permits require Planning Board review. Please see Sections 2.2 and 2.3 of the Tree Preservation Law for more information and application requirements.

**APPLICATION FOR TREE REMOVAL PERMIT**

Application is hereby made for a Tree Removal Permit in conformance with the Village of Upper Nyack Tree Preservation Law (Local Law 4 of 2021).

Requirements:

- Submit 1 copy of this application form
- Submit 1 copy of a letter from an ISA Certified Arborist describing the species, size and condition of the Trees subject to the Tree Removal
- Submit 1 copy of a property survey and/or sketch indicating the location of the Trees to be removed
- Tie tape provided by the Village around each Tree designated for cutting/removal
- Payment of associated fee at time of submission
- **NOTE: Additional submission materials will be required if Planning Board review is required**

The Village Forester will visit the property to make an inspection of the tree(s).

Further information may be required by the Code Enforcement Official's office, as provided by the Tree Preservation Law, if necessary for approval of this application.
