REGULAR MEETING April 15, 2021

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held via videoconferencing on Thursday, April 15, 2021 at 7:00 PM. In accordance with the Executive Order signed by Governor Andrew Cuomo, this meeting was held by video/teleconference. The meeting was recorded and transcribed.

POLICE REPORTS – PO Davies presented the CPD report to the Board. The following was noted and discussed: One car accident on Glenbrook and North Highland where a MV struck a deer. School, area, cultural, and religious checks are ongoing. No stolen vehicles reported. Two fraudulent unemployment scams reported in the Village. The Village of Nyack has also reported scams involving social media, as well as "grandparent scams," where the victim is called by someone claiming to be a family member that needs bail money. The county has also seen scams involving Orange and Rockland Utility customers, the scammers call the victims demanding a paid bill in the form of gift cards. Other local communities have seen people posing as utility workers and robbing residents. Eight traffic tickets were written this month in the Village, PO Davies noted this could be more due to a backlog in logging them at the county. Two parking tickets were issued in the Village. A business on North Highland Avenue experienced a larceny, license plates were stolen off of vehicles. Cooking oil thefts are continuing. Town of Clarkstown, 36 OD, 5 deaths (31 surviving). Rockland County, 112 OD, 9 deaths (93 surviving). PO Davies spoke to Mayor Tarapata earlier in the week to discuss monitoring truck traffic in within the Village. Sgt. Burke has spoken to traffic officers to show more attention to the area, and noted that if it's a local delivery it is legal. Trustee Dodge clarified that they are traveling through the Village of Upper Nyack, through the Village of Nyack, into the Village of South Nyack where they reenter 9W. Mayor Tarapata noted the No Parking signs on Lexow will

remain for another month. Trustee Epstein noted that Park Mobile, the parking app used in the Village of Nyack had a security breach, and urged residents that use the app to change their passwords.

There were no questions from the Board.

TREASURER'S REPORT -

Trustee Epstein made a motion to authorize the Treasurer to pay the DPW Building Bond \$65,000.00 to principal and \$15,156.25 in interest on May 1, 2021, seconded by Trustee Dodge and so moved.

Constitutional tax was filed and approved by the State, and the Village of Upper Nyack's tax cap calculation was filed and approved by the State.

7:15 PM Public Hearing – Tentative Budget

Mayor Tarapata read the Public Hearing Notice for the Tentative Budget.

The Treasurer provided an overview of the 2021-2022 budget. Real estate taxes increased 1.6% over the prior year. Film revenue for the Village is expected to increase. Village will receive \$100,000 in CHIPS grants. Mortgage taxes set to increase this year, real estate sales are up within the village. Sales take revenue is expected to decrease. Expenses for the Village include improvements at the preserve, investing in new technology at Village Hall, as well as lighting, Wi-Fi, and other repairs at the Old Stone Meeting House. Two paving projects are also expected this year, in addition to the sidewalk project along North Broadway. Majority of Village revenue is spent on the sewer bill and carting contract.

Trustee Dodge motioned to open the Public Hearing, Trustee Rothchild seconded and so moved.

Treasurer stated it is difficult to create an average, but the increase to residents would be minimal.

7:30 PM Public Hearing – Noise Law

The Clerk Typist read the Public Hearing Notice for the Noise Law.

Mayor Tarapata read the legislative intent of the law:

The making and creating of unreasonably disturbing or excessive noise within the Village of Upper Nyack is a condition which has persisted, and the level and frequency of occurrences of such noises continues to increase. These noise levels are a detriment to the public health, comfort, convenience, safety and welfare of the citizens of the Village. It is the intent of this Local Law to balance the rights of residents and property owners to use their property in a reasonable manner with the rights of others in the Village to be free of excessive, continuous, unnecessary or disturbing noise.

Mayor Tarapata noted the Board has met with noise monitoring firms and elected officials of other towns such as Dobbs Ferry that have implemented similar statute to create this law. Mayor Tarapata also noted in speaking with these firms and towns it was discovered that using decibels is not enforceable.

Mayor Tarapata noted read the referrals from Rockland County, Town of Clarkstown, and Village of Nyack.

Trustee Dodge motioned to open the public hearing, Trustee Epstein seconded, and so moved.

Submitted written comments from the public are attached to the minutes.

Connie Coker, Village Resident, spoke in support of the law and noted the toxins in the air as a result of gas powered leaf blowers in addition to the noise.

Diane Greenwald, Village Resident and Chair of Green Committee. Diane moved to the Village in 2018 with her husband and noticed the "near constant drone" of leaf blowers. Diane noted several Westchester communities that have similar regulations, and has sharply reduced the use of gas powered leaf blowers.

Tony Berman, Village Resident asked how many pro vs. con written comments were received. Trustee Dodge answered there were many more in favor of the law than not.

Carolyn Cohen, Village Resident, lives next to the ship yard. Carolyn stated the shipyard should have to regulate their nose level in addition to what is already stated in the law, as the noise coming from the shipyard is continuous.

Meave Tooher, ESQ., representing Goosetown Environmental Action, spoke on how this law should have a more quantitative approach that the law as it is currently written wouldn't result in a reduction of noise. She also stated that the fines are inadequate in regards to businesses like the shipyard that repeatedly break the law.

Sue Smith, Village Resident, requested the Board address the enforcement of the three hours on, 30 minutes off part of the law. Mayor Tarapata stated that the Code Enforcement Officer would be responsible for the enforcement.

Morton Korn, Village Resident, lives next to the shipyard and stated the noise is unbearable, and is unable to enjoy his property and that the noise has been detrimental to his mental health, expressed concern regarding the enforcement of the law.

Carol Lusignan of School Street, 18 year Village resident noted a lot of noise specific to landscaping. Also expressed interest in a quantitative approach to the law.

Mayor Tarapata stated that the Public Hearing will be open until next month's meeting. Written comments from the public will be available on the Village's website.

There were no further comments from the public.

Trustee Rothchild moved to adjourn the Public Hearing for this meeting and continue at the May 20, 2021 Regular Board Meeting. Trustee Esmay seconded, and so it was moved.

8:00 PM Continuation of Public Hearing- Tree Preservation Law

The Clerk Typist read the Public Hearing Notice for the Tree Preservation Law.

Mayor Tarapata read the legislative intent of the law:

- 1. The Board of Trustees of the Village of Upper Nyack has determined that both the existing character of the community and the control of erosion are highly dependent on maintaining the wooded landscape and hereby enacts this Local Law for the following purposes:
- 1.1. To control and regulate indiscriminate and excessive removal, cutting and destruction of Significant Trees in order to regulate and prevent conditions which result in increased surface runoff, soil erosion, and pollution of surface waters including, but not limited to, the Hudson River, and to require the planting of replacement trees where removal of Significant Trees is reasonably necessary, in order to prevent the above-referenced environmental harms.
- 1.2. To preserve an important attribute of the Village by encouraging owners of existing

developed lands and developers to reduce the removal of canopy trees and mature trees when making improvements to real property.

1.3. To maintain the stability and value of real property in the Village by preserving existing Significant Trees and woodland aesthetics, and to protect and enhance the aesthetics and views of the Village from the Hudson River.

Mayor Tarapata noted the law was revised after the public comments in January.

Trustee Dodge motioned to open the public hearing, Trustee Rothchild seconded, and so moved.

Jillana Sinnott, Board Secretary and Village Resident, noted the change of measurement in the law and how the criteria needs to be clear for those submitting to the Village Zoning Board.

Mayor Tarapata stated the law was developed with the Planning Board Chair, Village Forrester, and Land Use Attorney.

Peggy Kurtz, Village Resident expressed the removal of older trees and quality of life. Stated she is in favor of reducing the DBH, but doesn't understand the increase in trees that can be removed in the law, and suggested a list of specific trees to encourage certain species in instances where trees are replaced.

Trustee Epstein asked if there was a way for a dangerous tree to get fast tracked for removal. Mayor Tarapata noted that the Village already has such protocols in place. Noelle C. Wolfson, Village Land Use Attorney, noted Article 3 of the law for reference.

Peggy Kurtz asked why there is an increase in the number of trees that can be removed in a two year period. Ms. Wolfson explained that the increase comes in the number of dead or dying trees, however when upwards of six trees are to be removed, you would need to consider a replanting plan that would go to the Village Planning Board for Review.

Mayor Tarapata read the written public comments (attached).

Mayor Tarapata read the referrals from the Town of Clarkstown and Rockland County Department of Planning in regards to the law.

Trustee Rothchild noted the removal of willow trees years ago on North Broadway as an example of why the law was created.

Mayor Tarapata stated the exemptions will be posted to the Planning Board website.

Noelle Wolfson noted there was a typo in section 2.2.1.2 13 inches of larger, was meant to read 13 inches or smaller.

Trustee Rothchild motioned to adopt the law with the typographical correction to Section 2.2. Trustee Esmay seconded, and so adopted.

Bid # PV-01-2021 Paving Program- Pavement re-surfacing Bid Opening Review

The Clerk Typist read the Public Notice.

There was one bid received for Bid # PV-01-2021. Mayor Tarapata noted she was disappointed the bid was over \$100,000, and the Village has a grant for \$75,000. After reviewing the costs with the Village Engineer and Village Treasurer it was decided that the Village can afford this project. Village Engineer Dennis Letson is reviewing unit costs of the bid and may be able to develop a plan where Tilcon would pave Kuyper and have Goreman perform a resurfacing on Palmer Drive. Mayor Tarapata spoke with Clarkstown Town Supervisor George Hoehmann and was informed that the Village would receive approximately \$90,000 through the town from the State and Federal government that could cover the difference in cost. The Mayor recommended the bid be accepted.
