## REGULAR MEETING MINUTES AUGUST 19, 2021

The Regular Meeting of the Board of Trustees of the Village of Upper Nyack was held at Village Hall on Thursday, August 19, 2021 at 7:00 PM.

POLICE REPORTS – Clarkstown Police Officer Niles Davies and Sgt. Fratianni provided the report for the month. There were four motor vehicle accidents (MVA) in the Village. One MVA with injuries on Glenbrook and Highland Ave. The other three MVAs were without injury and occurred on North Highland Avenue, North Broadway, and Old Mountain and North Midland. One fire call for a dumpster fire on Lexow. Two juvenile calls: trespassing at Upper Nyack Elementary, in both instances the juveniles had left before officers arrived. Six sound ordinance calls on: Birchwood Ave (2), Jewett Road, Fairview Avenue, Wannamaker at North Midland, Nyack Field Club. Two instances of property damage: North Broadway – truck hit stop sign, Castle Heights Avenue – truck took down wires. One report of a person rummaging through recycling on Camboan Drive – gone on arrival. One call of a suspicious person on Badi Drive – male on bike with light, gone on arrival. School, area, cultural, and religious checks are ongoing. County-wide overdoses: 213 YTD, resulting in 37 deaths (176 survived). Town of Clarkstown overdoses: 67 YTD, resulting in 12 deaths (55 survived).

Larry Nathanson, Village Resident inquired about the Sound Law enforcement in regards to the Nyack Field Club movie nights on Fridays. PO Davies provided his contact information with Larry to contact him directly the next time it is an issue.

Trustee Dodge mentioned a resident complaint sent via email to the Board regarding the increase of speeding within the Village. PO Davies stated he will look into having a traffic count done in the Village and sending

unmarked cars to enforce.
