VILLAGE OF UPPER NYACK BOARD OF TRUSTEES RESOLUTION

NOTICE OF INTENT TO SERVE AS LEAD AGENCY FOR THE SEQRA REVIEW OF THE ANNEXATION OF PROPERTY FROM THE UNINCORPORATED PORTION OF THE TOWN OF CLARKSTOWN INTO THE VILLAGE OF UPPER NYACK AND THE ADOPTION OF A LOCAL LAW APPLYING A VILLAGE ZONING DESIGNATION TO SUCH PROPERTY SHOULD ANNEXATION BE APPROVED.

WHEREAS, on January 20, 2021 a petition (the "Annexation Petition") to annex the properties located at 554 N. Highland Avenue, Upper Nyack, NY; 536 N. Highland Avenue, Upper Nyack, NY; 530 N. Highland Avenue, Upper Nyack, NY; and 500 N. Highland Avenue, Upper Nyack, NY, more particularly described on the Clarkstown Tax Map as 59.12-1-15, 59.12-1-16, 59.12-1-17, 59.12-1-18, 59.12-1-19 (the "Annexation Properties") was submitted to the Town Board of the Town of Clarkstown by the owners thereof and was also filed with the Village; and

WHEREAS, the annexation petitioners have submitted a Short Environmental Assessment Form ("EAF") in support of the Annexation Petition and the application of Village zoning to the Annexation Property should annexation be approved pursuant to the New York State Environmental Quality Review Act ("SEQRA");

WHEREAS, based on a review of the EAF, the proposed action is classified as an UNLISTED Action under SEQRA because the total acreage of the Annexation Properties is approximately 11.38 acres, which falls below the Type I thresholds for annexation petitions and zoning amendments in 6 NYCRR 617.4.(SEQRA list of Type I actions);

WHEREAS, based on a review of the EAF and the Annexation Petition the Town Board of the Town of Clarkstown is an Involved Agency in the SEQRA review of the Action because its approval will be required for the proposed annexation to proceed; and

WHEREAS, the Village Board of Trustees proposes a coordinated review of this Action pursuant to the SEQRA Regulations section 6 NYCRR 617.6.

NOW THEREFORE be it:

RESOLVED, that the Village Board of Trustees of the Village of Upper Nyack hereby classifies the Action as an UNLISTED action under SEQRA and declares its intent to serve as Lead Agency for the SEQRA Coordinated Review of this Action. The Village Clerk is hereby authorized to circulate a Lead Agency Notice and supporting documentation to the Town Board of the Town of Clarkstown as an Involved Agency in this SEQRA review. Involved agencies shall be given 30 days from the date of transmittal of the Lead Agency Notice to consent to the Village Board of Trustees serving as Lead Agency in the SEQRA review of this Action or challenge such Lead Agency designation.
