ANNUAL MEETING September 24, 2020

The Annual Meeting of the Board of Trustees of the Village of Upper Nyack was held virtually on Thursday, September 24, 2020 at 7:00 PM.

The Oath of Office was taken, earlier in the day at Village Hall by the following Village Officials:

Kennon Rothchild III (Trustee), and Jeffrey Epstein (Trustee). All terms are for 2 years.

The Village Clerk read the public hearing notice.

Mayor Tarapata opened the meeting. Trustee Esmay will continue to serve as Deputy Mayor.

The Mayor read opening remarks:

Mayor's comments

I want to welcome everyone to the Village of Upper Nyack Annual Organizational Meeting. This meeting is typically held early in April, after the Village elections in March. COVID 19 changed all that.

The postponed Village elections were held last week on September 15 and I want to thank everyone who voted, either by absentee ballot or in person, as well as our interpid poll workers.

I would like to congratulate Kennon Rothchild on his reelection and welcome Jeff Epstein to the Village Board of Trustees. Village government is only as successful as the people who volunteer to serve and we are fortunate to have these capable residents offering their time.

As I said before, the COVID pandemic upended many plans this year, but the Village was fortunate to be able to pursue several infrastructure projects.

The N. Broadway sidewalk to the Hook was completed after many years of work, through a grant of over \$150 thousand dollars from the Department of Transportation as part of the Mario M. Cuomo bridge construction. Also known as the Hudson River Greenway Trail, the possibility of getting grants for the sidewalk extension was initially suggested to us by the Rockland Riverfront Communities Council. With the increase in the number of walkers, joggers and bicyclists due to the pandemic, the timing of the sidewalk construction could not have been better.

The resurfacing of N. Broadway was also completed this summer. Micro surfacing N. Broadway will extend the life of the road for another 8-10 years.

We were also able to have Village Hall painted this summer and new railings will soon be installed on the porch.

Our Village Hall staff and DPW have been absolutely fantastic during the pandemic, making the adjustments needed to keep themselves safe, while fulfilling the needs of Village residents. We thank residents for understanding the need to close Village Hall and the Department of Public Works buildings to the public and for working within the new restraints on access.

We have found that videoconferencing meetings has actually led to increased resident participation and I hope we can continue to make videoconferencing part of our meetings when the pandemic is past and we can have meetings in person.

We continue to work on updating our Comprehensive Plan and hope to have that process complete by the end of the year. The Comprehensive Plan update will inform the updating of our Zoning Code and General Ordinance with the goal of making residents' interactions with Village Government and our Land Use Board clearer and more efficient.

There are challenges ahead, with reductions in state and county funding, but the Village of Upper Nyack is in very good shape financially and we plan to continue the high level of service that residents have come to expect.

The Board did make some recent changes to the schedule of fees. No other changes at this time.

Noted by the Mayor that online training will continue and the DPW will do their training in October.

The Village Clerk will send information for online training to all staff & board members.

The Board discussed the adoption of LGS-01 Retention and Disposition Schedule for NY Local Government Records and as the subject matter list for FOIL requests.

Motion by Trustee Dodge, BE IT RESOLVED THAT;

By the Board of Trustees of the Village of Upper Nyack that Retention and Disposition Schedule for New York Local Government Records, issued pursuant to Article 57-A of the Arts and Cultural Affairs Law, and containing legal minimum retention periods for local government records, is

hereby adopted for use by all officers legally disposing of valueless records listed therein.

FURTHER RESOLVED, that in accordance with Article 57-A: a) only those records will be disposed of that are described in Retention and Disposition Schedule for New York Local Government Records after they have met the minimum retention periods described therein: xxiv b) only those records will be disposed of that do not have sufficient administrative, fiscal, legal, or historical value to merit retention beyond established legal minimum periods,

Second by Trustee Rothchild and so moved.
