#### HISTORICAL MARKER- 311 North Broadway

Tom Perry, resident and Nyack High School teacher, appeared before the Board to request permission to install an historical marker commemorating the Skirmishes at Sarvent's Quarry in 1776-1777. Mr. Perry came with 5 of his students who gave a presentation to the Board of how they will be participating by looking on the property for artifacts and fundraising to cover the cost of the marker and installation. The students will also work with the Historical Society of the Nyack's in gathering information. The property owners at 311 North Broadway have no issue with the location of the marker, as the Mayor spoke with them. Mayor Tarapata spoke to the students telling them the Board applauds their research and dedication.

Trustee Rothchild made a motion to accept this idea in recognizing the dedication to research by this group and to allow the installation of this historical marker in the village right-of-way, seconded by Trustee Esmay and so moved.

## WIRELESS TELECOMMUNICATIONS FACILITIES LAW
