REGULAR MEETING June 18, 2020

The Regular meeting of the Board of Trustees of the Village of Upper Nyack was held Thursday, June 18, 2020 at 7:00 PM. In accordance with the Executive Order 202.1, this meeting was held by video/teleconference. The meeting was recorded and transcribed.

POLICE REPORT - PO Kennedy presented the report.

There were 157 calls for service;;1 motor vehicle accident (9W & Christian Herald) with 3 tickets issued; 26 medical calls; continuing area checks and cultural and religious organizations; 17 alarms (burglar and fire); 1 trespass complaint; 1 larceny (10 bicycles from TOGA bike shop); 6 ordinance violations (noise-juveniles at the elementary school) 6 domestic calls. Other items discussed: Increase in MV larcenies in Nanuet; Hot rod speeding at Palisades Mall, Nanuet Mall and 59 & Palisades; double homicide with suspect caught

Discussion regarding overdoses:

Rockland County 104 ODs year to date (19 resulting in death)

Town of Clarkstown: 38 ODs (7 resulting in death)

No parking on Locust Dr. & Lexow Ave. is working well.

Mayor Tarapata asked for the no parking signs to be switched to the south side of the street. PO Kennedy noted there were no V&T for no parking this month.

<u>TREASURER'S REPORT</u> – Submitted for review from Treasurer Fortunato. Treasurer Fortunato noted that the Sewer bill to the Town of Orangetown for the annual charge and the repair of the pump station is \$459,772.80.

Discussion: The Village received a letter of engagement for the audit of Upper Nyack financial statements from Berard & Associates, 44 Park Ave., Suffern, NY 10901 for the Fiscal year ending 5/31/2020. The village budgeted \$20,000 and the fee that will be charged is \$15,000. The Village used this firm in 2016 but it has now merged and formed this

new firm.

Trustee Diamond made a motion that the Board accept the engagement letter of Berard & Associates to conduct an audit of the Village's financial statements for \$15,000 and to allow the Mayor to sign, seconded by Trustee Rothchild and so moved.

Donna Zlocki and Gabriella Zlocki, 115 Larchdale Avenue, Upper Nyack, NY 10960, appeared before the Board for relief from the "temporary moratorium on commercial or residential special use permit and special use permit renewal applications," pending review and amendment of the Comprehensive Plan and related Zoning Laws pertaining to said subject matters.

Donna Zlocki and Gabriella Zlocki are seeking relief from the moratorium so that they may make an application for Special Permit to the Zoning Board of Appeals to house chickens on their property.

<u>Discussion – Proposed law for permanent no parking on one side of Lexow</u> <u>Ave and Locust Ave</u>

The Board had agreed at the regular meeting in May to request that CPD place No Parking signs on one side of the street both on Lexow Ave. and Locust Drive and wanted to know from the residents if it was helpful? Those who spoke: Jeffrey Epstein, Jillana Sinnott

Mr. Epstein noticed that the problem had dissipated and was trending

towards a non-issue. It occurs mostly on weekends. It seems to be working and it would be good to give it more time before deciding on making it permanent. Since the parking affects the residents at the end of the block, closest to N Broadway, he would think any decisions about painting the berm should be left to the wishes of those residents.

Jilliana Sinnott noted that last year, prior to COVID-19, there was a lot of parking on Locust Dr. and as summer comes it may be more of an issue. Currently the signs from CPD seem to be working.

Mayor Tarapata and the Board decided to take no permanent action at this time.

<u>Discussion – Seasonal ban on 2 stroke/gas powered leaf blowers</u>

Mayor Tarapata reported that she had been in contact with Mayor's and Supervisor's from other jurisdictions that have leaf blower bans or restrictions. The Mayor proposed a public meeting for the community to participate in a panel discussion with the following Officials: Chris Burdick, Supervisor, Town of Bedford, NY, Niki Armacost, Mayor, Hastings on Hudson, NY, and Nancy Adams, Councilwoman, Town of Maplewood, NJ, to be held on Thursday, July 9, 2020 at 7 PM.

The public would be allowed to ask questions and discuss how the bans have worked in those communities.

Trustee Rothchild agreed that this will be open and transparent and there is such a divide on this issue that it would be beneficial to learn what works. Those from the public who spoke:

MICROSURFACING OF NORTH BROADWAY

The Village obtained two bids from the State Bid OGS contracts, Indus and Gorman Bros. Inc. The Village agreed to contract with the Gorman Bros. Inc. for the mircrosurfacing project from Nyack Beach State Park to the Nyack line. The contracted amount will be \$144,328.00. Additional money was added to the original bid to cover the cost of removing or grinding down the yellow stripe that exists in the roadway. Mircosurfacing cannot be applied on top of the striping.

<u>Discussion by the Board:</u> It was noted that doing this work on N Broadway, a road that lends itself to this kind of surface, will extend the life of the road and may not need to be milled and paved for about eight years. The DPW can repair the berms.

Trustee Dodge made a motion to authorize the Mayor to sign the contract with the Gorman Bros. Inc. in the amount of \$144,328.00 for the microsurfacing of N. Broadway as outlined in the bid dated June 18, 2020 and seconded by Trustee Esmay and so moved.

SOIL BORINGS AT THE PRESERVE PROPERTY

It was decided that the bid would be submitted to the DOL to obtain the prevailing wage and rebid.
