RESOLUTION AUTHORIZING FUNDS RELATED TO A DASNY CAPITAL GRANT THROUGH THE NEW YORK STATE SENATE FORTHE MULTI-USE PATH THROUGH THE RIVER HOOK PRESERVE

- WHEREAS, The Village of Upper Nyack has the opportunity to receive a \$75,000 DASNY capital grant through the New York State Senate for the purpose of a multi-use path through River Hook: the Hester Haring Cason Preserve, and

RESOLUTION TO MOVE FUNDS FROM RESERVES FOR THE CAMBOAN UNDERDRAIN PROJECT
