Discussion: Purchase of South Nyack Surplus Equipment

The Village has the opportunity to bid on equipment from the South Nyack DPW: A 4-ton asphalt trailer with torch and heated deck, and a F350 pickup with v-plow and toolbox.

The asphalt trailer would provide the Village with increased efficiency, as the current trailer holds 2-tons and requires multiple trips to the asphalt plant when patching potholes. The 4-ton trailer can maintain the heat of the asphalt over two days, and includes a torch for pre-heating road surface for better patching. This trailer was purchased for South Nyack in 2020 for \$32,358 and used less than five times. The Mayor is to bid \$22,000. The Village's current trailer can be surplused and sold for approximately \$9,000.

The Village has many uses for the Ford 350, the Code Enforcement Officer can use it for enforcement actions and not tie up a DPW dump truck. Additionally, the Ford 350 is the ideal size to plow certain dead narrow streets and the path on the Preserve. The F350 is a 2015 diesel, has 58k miles, a v-plow and attached tool box. Maintenance record known.

Book value about 40K without the plow. Proposing a bid of \$23,000

Trustee Esmay motioned to approve bidding for these items up to \$45,000, Trustee Dodge seconded, and so approved.
